1. Coordinator Updates

a. Grants – CPW approved the Montelores Coalition's letter of intent to apply for the spring RPI planning grant. Final application is due on April 30th. Michelle met with Morgan at the state, who suggested that the coalition consider the development of a tool that can be used for mapping conservation needs and projects in the region.

She sent links for other coalitions' tools that are being used. BLM, USFS and NPS did not see a use for such a tool. Upon further discussion, it was determined that a tool would be more useful for citizens and regional conservation groups to stay informed and communicate with each other. The board requested a demonstration of a successful tool. Jamin offered to give a demonstration, which he has done for other regional partnerships.
